Minutes of the Customs Clearance Facilitation Committee Meeting (CCFC) held on 24.09.2018 at 04:00 P.M in the Board Room of Custom House, Kolkata

The Customs Clearance Facilitation Committee Meeting was held in the Board Room of Custom House, Kolkata on 24.09.2018. The meeting was presided over by the Chief Commissioner of Customs, Kolkata Zone, Kolkata.

The Chief Commissioner of Customs, Kolkata Zone welcomed all the members. It was decided to first deliberate on the action taken reports of the points discussed in the last CCFC meeting held on 20.08.2018 and then the fresh points to be taken.

Review on the points discussed in the CCFC meeting dated 20.08.2018:

1. The representative of Textile Committee informed that there is a pendency of Rs. 3,24,000/- as test charges from groups and SIB.

Action Taken: The Deputy Commissioner in charge informed that letters to the respective importers have been sent with direction to pay the outstanding test charges to the Regional Office of the Textiles Committee, Kolkata at the earliest with copies to the concerned CHAs and CCHAA, so that they can pursue the matter with the concerned importers.

Also a letter has been sent to the System Manager for updating the list of importers, having outstanding test fees for Textile Committee (Kolkata), in the RMS instruction.

2. The Deputy Director of Plant Quarantine informed via email that a few Bills of Entry are not getting redirected to plant quarantine system and those Bills of Entry got cleared without the NOC from PQ.

Action Taken: It was informed by the officer concerned that the Bills of entry filed for any plant products are forwarded to PQ authority for NOC through EDI SWIFT System automatically. It was requested that the PQ authority should provide the list of items to Customs for which PQ NOC is mandatory but not being referred to them by the System.

Following fresh issue(s) were discussed in the CCFC meeting dated 24.09.2018:

1. The representative of CCHAA informed that they are facing problem in getting test reports from Wild Life Crime Control Bureau (WCCB) because in terms of notice No.255 dtd. 16.08.18 issued by WCCB, only Customs ID card holders (F/G/H categories) will be entertained by them. He has requested that due to shortage of F/G/H card holders, the test report may be given to the person authorised by the CHA/ Exporter.

They would like to know the reason for issuance of such order, so that alternative methods may be explored.

Response/Decision:

The representative samples are being forwarded to the Participating Government Agencies (PGAs) through departmental officers for testing purpose. The Chief Commissioner advised the Participating Government Agencies to mail the test reports to the concerned DCs/ACs directly for speedy clearance of import/ export consignment(s). The hard copy of the same may also be forwarded through speed post.

There were some agenda points raised by the Engineering Export Promotion Council (EEPC) which were not discussed as no representative from EEPC was present in the meeting.

The meeting concluded with a vote of thanks to the chair.
