# Minutes of the Trade Facilitation Committee Meeting (TFC) held on 23.01.2019 at 1200 Hrs in the Board Room of Custom House, Kolkata

The Trade Facilitation Committee Meeting was held in the Board Room of Custom House, Kolkata on 23.01.2019. The meeting was presided over by the Commissioner of Customs (Port).

The Commissioner of Customs (Port) welcomed all the members.

#### Following issues were discussed in the meeting:

### A. Agenda Points submitted by CCHAA:

1. The representative of CCHAA informed that clarification is required as whether submission of documents per E-Sanchit, in reply to a query, is to be considered as amendment to a Bill of Entry or not.

# Response/Decision:

It was informed that it is not an amendment of Bill of Entry.

2. The representative of CCHAA informed that all consignments of buff leather are being referred to WLA but not other consignments like cow leather etc. Hence, the CHAs have to visit Wild Life Authority in case of export of items made of buff leather.

## Response/Decision:

The SCP, Export informed that buff leather is among the items categorically identified for WLA inspection. The Commissioner inquired if the Shipping Bills are being referred to WLA through SWIFT. The SCP, Docks could not give clear reply in this matter. The Commissioner said that all consignments are forwarded through SWIFT. There should not be manual reference to WLA authorities, unless

there is such direction from their HQs. He also directed DC, Exports and DC/AC, Docks to examine the issue and take corrective measures if required. This issue will also be referred to Nodal Officer, SWIFT.

[Action: DC/AC, EDI]

3. The representative of CCHAA informed that examination and LEO of Export cargo may be done by only one wing i.e. either Appraising or Preventive.

#### Response/Decision:

The Commissioner stated that which cadre does the examination work should not be the concern of Exporters/CBs. However, he directed that the examination process should be conducted at one time by EO/PO and Superintendent. The Commissioner directed the ACs of Docks and CFSs to look into this matter.

[Action: DC/AC, CFSs and Docks]

#### B. Agenda Points submitted by FIEO:

1. The representative of FIEO informed that for ref. Shipping Bill no. 2433977 dated 25 Nov 2016, samples were drawn from the consignment for assessment of DBK. Thereafter, since GST was to be introduced, the shipment was purged from ICEGATE and DBK for this shipment has not been cleared.

#### Response/Decision:

The Commissioner stated that TFC meetings are not the proper forum for discussion of individual cases. The matter will be taken up separately. Drawback section will reply to FIEO on this case.

[Action: DC/AC, DBK]

2. The representative of FIEO informed that clarification is needed on procedure for centralized AD code registration for exporters who are having single AD for multiple ports/places of export.

#### Response/Decision:

The Commissioner stated that the AD code registration is done Port wise. DG (Systems) had informed that centralized AD code registration may be introduced for single AD users but there is no update on that. The representative of CCHAA informed that AD code is given by local Bank branches and hence AD codes would be different in a different location. Hence, the AD code procured in a location cannot be used in a different port of Export. The Commissioner (Port) directed DC (EDI) to take up the matter with DG (Systems).

[Action: DC/AC, EDI]

# C. Agenda Points raised by ASIC discussed during the course of meeting:

The representative of ASIC informed that SCMT Regulation will come into force from 1<sup>st</sup> March, 2019. He requested the Commissioner to hold a meeting with all the stakeholders to have feedbacks on the Regulation.

#### Response/Decision:

The Commissioner stated that a meeting would be held next week.

[Action: DC/AC, SPS]

The meeting ended with the vote of thanks to the Chair.
