Logistics Service Providers are the backbone of Supply Chain in India for the EXIM trade. **CAI, AMTOI, FFFAI, ACAAI** members and logistics service providers have always stood shoulder to shoulder with exporters and importers throughout every crisis. We have always maintained the continuity of services even during the most challenging periods such as strikes, storms and other Force Majeure conditions.
