## MINUTES OF THE CUSTOMS CLEARANCE FACILITATION COMMITTEE (CCFC) MEETING HELD ON 28.05.2021 (THROUGH WEB CONFERENCING)

The meeting of the Customs Clearance Facilitation Committee (CCFC) of Kolkata Customs Zone was held on 28.05.2021 at 04:00 PM under the Chairmanship of Shri Pramod Kumar Agrawal, Chief Commissioner of Customs, Kolkata Customs Zone. In view of the Government directives on account of the threat of COVID-19, the meeting was conducted via Web Conference.

The Chairman welcomed all the members and opened the conference for discussions. Thereafter, the Chair considered the discussions on the agenda points as appended herein below:

Issue 1	Sponsored by Sudip Dey, Vice President, Calcutta Customs House Agents	
	Association (CCHAA):	
	Information on SOP of all PGAs for clearance of EXIM cargo, was sought for operating under Lockdown, which is likely to be extended further.	
Remarks of Department	The matter has been discussed during the meeting. It has been informed by Principal Commissioner of Customs (AP & ACC) that, as directed, letter regarding the issuance of SOP by PGA's have been sent to the concerned 05 PGAs viz. Regional Plant Quarantine Station, Wildlife Crime Control Bureau, Food Safety and Standard Authority of India, Animal Quarantine and Certification Service & Central Drug Standard Control Organization for furnishing the desired information. Reply is awaited from PGAs but Mr. Subburaj M. Authorized Officer of FSSAI being present in the meeting will pronounce their devised SOP.	
Remarks of PGAs	The matter has been discussed during the meeting. It has been informed by the Authorised officer, FSSAI that for SOP regarding COVID related highly essential services has been devised by their Headquarters. The SOP pronounces that, all consignment clearance has to be done within five days. And in case of Oil and Pulses, they have to clear the consignments within three working days and would issue NOC within 2 hours. They would be working 24*7 for scrutiny of the consignment and added that they had appointed nodal officer(s) and special officer(s) for the same.	
	Dr. Jimlee Sarmah representing Animal Quarantine was very much present in the meeting but her voice was inaudible during the meeting. In an email communication sent later she informed that AQCS upholds their commitment towards trade facilitation & ease of doing business following their mandate during the ongoing COVID19 pandemic,	

while dealing with import clearances of highly perishable items like fish & fishery related livestock products & that too with minimal staff strength on rotation basis. They clear the consignments within 30-60 minutes of receipt of documents. She also added that cross border trade has been facilitated across all POE inclusive of two newly notified LCS to the satisfaction of all the stake holders. She further apprised that all the stakeholders were informed to submit the documents and Customs sealed samples etc. for availing their decision as per SOOP (Single Day Decision Policy) or within 8 working hours for all imported consignments falling under the purview of AQCS Kolkata. She also provided their email id (roagcser.kol-dadf@gov.in) and phone no. (033-25196777) for dealing with any query / assistance to be responded within 8 working hours of receipt.

Dr. K.K. Halder from ADC (I) joined the VC and stated that guidelines in form of Circular is already there specifying how to deal with in case of urgency and it provides round the clock availability of officers "on call" for expeditious clearance of cargo.

### Direction of the Chair

The chair has requested to all PGA to share their SOP to all the CHA with a copy to the Custom Department mentioning the name(s) of the nodal officer(s) & special officer(s) posted at different locations. The Chair has also requested them to notify the alternative arrangements & name of the coordinator, if any, at any particular customs location, where the PGA is not directly available.

The Chair also mentioned that similar SOP will also be issued by Customs Department as well, as the Ministry of Finance is contemplating the same. The Chair has also directed both the Principal Commissioner of Customs to share the contact no. concerned Custom officials to every PGAs and also take contact number of every PGAs for any communication adding further to communicate with all the PGAs regarding the issuance of SOP in this regard at the earliest. The Chair also directed to communicate with the Postal Appraising Department for publication of SOPs as well as a lot of issues is related to them.

### raised during the Meeting

Extended his vote of thanks to the Customs Department and shared his experience during lock down period in respect of clearance of urgent consignments. He further mentioned about Shri Basant Kumar, Joint Commissioner of Customs (Port), Shri D. Satish, Joint Commissioner (Port) and Shri Sydney D'Shilva, Customs Additional Commissioner of Customs (A &A) for their cooperation in clearance of the consignments. He also added that, Shri Basant Kumar, JC (Port) personally contacted the WCCB officer for faster clearance of the consignments & Shri Sydney D'Shilva also extended his total support at the Airport for faster clearance of the consignment during the lock down period.

### Comments of the Chair

The Chair assured him on behalf of both The Principal Commissioners and himself that similar cooperation will be continuing and informed that the Department is available 24\*7 for clearance of the consignment. The Chair also insisted on issuance of some guidelines to declare Customs Departmental Officers, particularly those engaged in customs job, being a part of the essential service, and directed such officers & staff to carry their departmental ID Card(s) and put appropriate stickers on vehicles, as well, while plying to office during the lock down period. He also reiterated to abide by the State imposed restrictions in this unprecedented situation and vie for achieving maximum output with minimum physical presence by leveraging all technical aids viz. email, whatsapp, telephone etc. The Chair reminded all stakeholders to come up with any suggestions and/ or guidance etc. for complete cooperation and smooth functioning of Customs facilitation as usual.

Subburaj of FSSAI over phone but since the voice was not clear the Chair directed both the

Principal Commissioners to hold separate webinars with the PGAs regarding issuance of

SOPs and in such meeting the CHA etc. should also be accommodated for all better reasons.

The contact numbers of all concerned should be exchanged and kept note of by all

concerned so that expeditious clearance can be done in this ongoing emergency situation. The

Chair also mentioned that it was utterly surprising that the nodal officer from CPCB did not

have the number of any Custom Officers, hence the number of the key officers like Shri

Basant Kumar, Joint Commissioner of Customs (Port) and Shri Sydney D'Silva, Additional

Commissioner of Customs (A &A) should be shared and the numbers of the higher officials

of the PGAs should be procured as well for keeping it handy in case of any emergency.

The meeting ended with a vote of thanks to the Chair.
